For information - FuelEU Maritime: latest information

Dear Members,

I would like to share with you the latest information we have on the implementation of FuelEU Maritime.

The draft secondary acts opened for consultation in April were approved (ref: C-13523 of 28-03-24). The implementing acts on [verification activities](#) and on [monitoring plans](#) will be published early July. The delegated act on [accreditation of verifiers](#) will be published in late summer, but the Commission is already in contact with the Member States' authorities on the topic.

The Commission updated the timeline for the three next acts, which they presented during the SEC meeting (updates in bold):

- Implementing act on communication on OPS
 - Public consultation: early July
 - Estimated date for adoption: September
- Implementing act on the FuelEU Database
 - Consultation with SAPS/ESSF: **early July**
 - Public consultation: September
 - Estimated date for adoption: end 2024
- Implementing act on the criteria for the acceptance of zero-emission technologies
 - Consultation with SAPS/ESSF: September
 - Public consultation: **October**
 - Estimated date for adoption: end 2024

In addition, the FuelEU database will be rolled-out step by step, starting with the functionalities for the monitoring plan, which will be available in July. You can find below a slide explaining how this database will fit in the Thetis environment.
