#### **Mr Richard Hext of Anglo-Eastern elected new Chairman of the Hong Kong Shipowners Association**

At the Hong Kong Shipowners Association Annual General Meeting (AGM) held yesterday (19 November 2025), Mr. Richard Hext of Anglo-Eastern Ship Management Limited was elected Chairman of the Association. Mr. Hext succeeded Mr. Angad Banga, JP of the Caravel Group Limited, who stepped down after completing his two-year term as Chairman.

Mr. Kenneth Lam, JP of SeaKapital Limited was elected Deputy Chairman, succeeding Mr. Richard Hext. Mr. Qian Weizhong of COSCO Shipping (Hong Kong) Co Limited and Mr. Wang Yongxin of China Merchants Energy Shipping Company Limited were re-elected as the Vice Chairmen.

Mr. Angad Banga, JP, the outgoing Chairman, thanked members for their support to the Association during his term.

After the AGM, the Association hosted its annual cocktail reception, a highlight of Hong Kong Maritime Week 2025, which attracted more than 500 members and local and overseas distinguished guests. In his welcome remarks, new Chairman Mr. Hext paid tribute to the great work of Mr. Banga. Under his leadership in the previous two years, the Association initiated several major shipping events and projects, including the Hong Kong Global Maritime Trade Summit of the International Chamber of Shipping, the International Shipping Forum of Asian Shipowners' Association, the Greater Bay Maritime Forum, and the Maritime Talent Cultivation Alliance.

Mr. Hext also commended the past Chairman for his many other contributions, in particular "the superb synthesis of skills from the worlds of finance and shipping that he has deployed so effectively for the benefit of the Association".

When sharing his views about Hong Kong strengths, Mr. Hext commented that "Hong Kong's bilingual common law, unfettered movement of capital, attractive tax regime, unambiguous commitment to free trade and proximity to the Chinese Mainland are a unique combination. Meanwhile China is the largest economy in the world in terms of purchasing power parity, the global manufacturing superpower and the world leader in a host of industries that will define our and our kids' futures - including clean energy and battery technologies, AI and robotics, electric vehicles, drones, e-commerce and so on".

### Anglo-Eastern 宋睿之先生當選香港船東會新任主席

昨日 (2025 年 11 月 19 日) 香港船東會舉行會員周年大會。Anglo-Eastern Shipmanagement Limited 宋睿之先生當選為香港船東會主席，接替完成兩年主席任期的拓維集團 Angad Banga 太平紳士。

海瀚資本有限公司林詩鍵太平紳士當選常務副主席，接替宋睿之先生。中遠海運（香港）有限公司錢衛忠先生及招商局能源運輸股份有限公司王永新先生獲選連任為副主席。

卸任的主席 Angad Banga 太平紳士，感謝全體會員在其任內給予香港船東會的鼎力支持。
